COUNCIL OF THE DISTRICT OF COLUMBIA NOTICE

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, PL 93-198 (the Act), the Council of the District of Columbia adopted Bill No. 1-169 on first and second readings July 22, 1975, and August 5, 1975, respectively. Following the signature of the Mayor on August 13, 1975, this legislation was assigned Act No. 1-43, published in the August 25, 1975, edition of the D. C. Register, and transmitted to both Houses of Congress for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional review period has expired and, therefore, cites the following legislation as D. C. Law No. 1-31, effective November 1, 1975.

D. C. Law No. 1-31

In the Council of the District of Columbia

November 1, 1975

To amend the District of Columbia Income and Franchise Tax Act of 1947 as it affects unincorporated businesses.

Be it enacted by the Council of the District of Columbia,

That this act shall be known and may be cited as the "District of Columbia Unincorporated Business Franchise Tax Revision act of 1975".

- Sec. 2. Section 3(a)(15) of Title 3 of the District of Columbia Income and Franchise Tax Act of 1947 (D.C. Code, sec. 47-1557b(a)(15)) is amended by striking the figure "20" and inserting in lieu thereof the figure "55".
- Sec.3. This act shall apply with respect to taxable years beginning on and after January 1, 1975.
