IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JULY 19, 1996

To establish a program to provide early intervention services designed to meet the developmental needs of infants and toddlers, from birth through 2 years of age and their families, and to require the Mayor to establish a sliding fee scale for early intervention services based on the income of eligible families.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Early Intervention Services Sliding Fee Scale Establishment Act of 1996".

Sec. 2. (a) There is established in the District the Early Intervention Services Program ("Program") to provide early intervention services for infants and toddlers from birth through 2 years of age and their families. The program shall qualify the District to receive funds pursuant to the Individuals with Disabilities Education Act, approved April 13, 1970 (84 Stat. 175; 20 U.S.C. 1471 *et seq.*) ("IDEA").

(b) The Mayor may apply for federal funds pursuant to the IDEA to provide early intervention services under the Program.

Sec. 3. (a) The Mayor shall, pursuant to title 1 of the District of Columbia Administrative Procedure Act, approved October 21, 1968 (82 Stat. 1204; D.C. Code § 1-1501 *et seq.*), issue rules to implement the provisions of this act.

(b) The rules shall include a sliding fee scale, based on the income of the family, for early intervention services for infants and toddlers from birth through 2 years of age and their families.

Sec. 4. Fiscal impact statement.

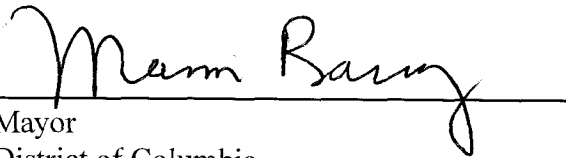
The Council adopts the fiscal impact statement in the committee report as the fiscal impact statement required by section 602(c)(3) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code

§ 1-233(c)(3)).

Sec. 5. This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), approval by the Financial Responsibility and Management Assistance Authority as provided in section 203(a) of the District of Columbia Financial Responsibility and Management Assistance Authority Act of 1995, approved April 17, 1995 (109 Stat. 116; D.C. Code § 47-392.3(a)), and a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in the District of Columbia Register.
