#### IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUNE 19, 1995

To amend the District of Columbia Business Corporation Act of 1954 to allow corporations to file 5-year reports instead of annual reports and to increase the fees associated with filing reports.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Business Corporation Five-Year Report Amendment Act of 1995".
