D.C. LAW 12-156

"School Transit Subsidy Act of 1978 Amendment Act of 1998".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 12-190 on first and second readings, May 5, 1998 and June 2, 1998, respectively. Following the signature of the Mayor on June 17, 1998, pursuant to Section 404(e) of "the Act", and was assigned Act No. 12-383 and published in the July 17, 1998, edition of the D.C. Register (Vol. 45 page 4617) and transmitted to Congress on July 21, 1998 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 12-156, effective October 7, 1998.

D.C. ACT 12-383

To amend the School Transit Subsidy Act of 1978 to permit disabled students over 19 years of age and under 22 years of age to participate in the school transit subsidy program.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "School Transit Subsidy Act of 1978 Amendment Act of 1998".

Sec. 2. Section 2(c) of the School Transit Subsidy Act of 1978, effective March 3, 1979 (D.C. Law 2-152; D.C. Code § 44-217(c)), is amended by adding a new paragraph (1-A) to read as follows:

**Section
44-217**


"(1-A) Notwithstanding paragraph (1) of this subsection reduced fares shall be available for children with disabilities, as defined by the Individuals with Disabilities Education Act, approved April 13, 1970 (P.L. 91-230; 84 Stat. 175; 20 U.S.C. § 1401), through the end of the semester in which children with disabilities reach 22 years of age;"

Sec. 3. The Council adopts the fiscal impact statement in the committee report as the fiscal impact statement required by section 602(c)(3) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(3)).


Sec. 4. This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), approval by the Financial Responsibility and Management Assistance Authority as provided in section 203(a) of the District of Columbia Financial Responsibility and Management Assistance Act of 1995, approved April 17, 1995 (109 Stat. 116; D.C. Code § 47-392.3(a)), a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Home Rule
