

D.C. LAW 12-201

"Summary Abatement of Life-or-Health Threatening Conditions Amendment Act of 1998"

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 12-175, on first and second readings, July 7, 1998 and September 22, 1998, respectively. Following the signature of the Mayor on October 13, 1998, pursuant to Section 404(e) of "the Act", and was assigned Act No. 12-487 and published in the December 4, 1998, edition of the D.C. Register (Vol. 45 page 8410) and transmitted to Congress on January 28, 1999 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 12-201, effective March 26, 1999.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA
OCTOBER 13, 1998

To amend An Act To provide for the abatement of nuisances in the District of Columbia by the Commissioners of said District, and for other purposes, to expand the definition of the term "life-or-health threatening condition" to include conditions that endanger the surrounding community.


BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Summary Abatement of Life-or-Health Threatening Conditions Amendment Act of 1998".


Sec. 2. Section 1 of An Act To provide for the abatement of nuisances in the District of Columbia by the Commissioners of said District, and for other purposes, approved April 14, 1906 (34 Stat. 114; D.C. Code § 5-513), is amended by striking the second sentence of subsection (c) and inserting the sentence "A life-or-health threatening condition means a condition that imminently endangers the health or safety of the tenant or occupant of the premises in a housing unit or housing accommodation, or that imminently endangers the health, safety, or welfare of the surrounding community." in its place.

Sec. 3. This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), approval by the Financial Responsibility and Management Assistance Authority as provided in section 203(a) of the District of Columbia Financial Responsibility and Management Assistance Act of 1995, approved April 17, 1995 (109 Stat. 116; D.C. Code § 47-392.3(a)), a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Home Rule

Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in the District of Columbia Register.
