Pursuant to Section 412 of the District of Columbia Home Rule Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill 12-694 on first and second readings, December 1, 1998 and December 15, 1998, respectively. Following the signature of the Mayor on December 29, 1998, pursuant to Section 404(e) of "the Act", the bill became Act 12-608 and it was published in the February 19, 1999 edition of the D.C. Register (Vol. 46, page 1309). The Act was transmitted to Congress on February 10, 1999 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DECEMBER 29, 1998

To amend Title 16 of the District of Columbia Code to require criminal records checks for individuals seeking to become adoptive parents of children and for individuals residing in foster family homes or other homes in which children are placed by court order, require that fees be paid for criminal records checks, and to provide penalties for individuals who disclose confidential information under the act.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Criminal Records Check for the Protection of Children Act of 1998".

Sec. 2. Title 16 of the District of Columbia Code is amended by adding a new Chapter 50 to read as follows:
