
NOTICE

D. C. Law 2-105

"Underground Excavation Enforcement Act of 1978"

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 2-246, on first and second readings May 30, 1978 and June 13, 1978, respectively. Following the signature of the Mayor on July 5, 1978, this legislation was assigned Act No. 2-217, published in the August 25, 1978, edition of the D. C. Register and transmitted to both Houses of Congress for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired and, therefore, cites the following legislation as D. C. Law 2-105, effective September 13, 1978.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

September 13, 1978

To amend the penalty provisions for violations during excavation in public space.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Underground Excavation Enforcement Act of 1978".

Sec. 2. Section 7 of the Act of June 18, 1898 (30 Stat. 477; D.C. Code, sec. 7-615) is amended by deleting the colon before the word "Provided" and inserting in lieu thereof a period and the following sentence: "The person obtaining such a permit shall abide by all conditions and provisions of the permit:".

Sec. 3. Section 8 of the Act of June 18, 1898 (30 Stat. 477; D.C. Code, sec. 7-616) is amended by deleting the words "five dollars nor more than one hundred dollars;" and inserting in lieu thereof the words "one hundred dollars nor more than one thousand dollars;".

Sec. 4. This act shall take effect pursuant to the provisions of section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act.
