

D. C. LAW 2-155

"Expanded Public Defender Service Board of Trustees Membership"  
Act of 1978"

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 2-241, on first and second readings, November 28, 1978 and December 12, 1978 respectively. Following the signature of the Mayor on December 28, 1978, this legislation was assigned Act No. 2-322, published in the January 26, 1979, edition of the D.C. Register, (Vol. 25, page 6986) and transmitted to Congress on January 19, 1979 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and, therefore, cites the following legislation as D.C. Law 2-155, effective March 6, 1979.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DECEMBER 29, 1978

To expand the membership of the Board of Trustees of the Public Defender Service, and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,  
That this act may be cited as the "Expanded Public Defender Service Board of Trustees Membership Act of 1978".

Sec. 2. Section 303 of the District of Columbia Court Reform and Criminal Procedure Act of 1970, approved July 29, 1970 (34 Stat. 655; D.C. Code, sec. 2-2223) is amended as follows:

(a) by striking the word "seven" in subsection (a) of such section and inserting in lieu thereof "eleven"; and

(b) by redesignating paragraphs (2) and (3) of subsection (b) as paragraphs (3) and (4) and inserting a new paragraph in such subsection which shall read as follows:

"(2) four of the eleven members of the Board of Trustees shall be non-attorneys and shall be residents of the District of Columbia.".

Sec. 3. This act shall take effect as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act.
