

D.C LAW 2-27

"Variable Licensing Periods Act
of 1977".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act (PL 93-198), the Act, the Council of the District of Columbia adopted Bill No. 2-126 on first and second readings June 28, 1977, and July 12, 1977, respectively. Following the signature of the Mayor on August 1, 1977, this legislation was assigned Act No. 2-61, published in the August 19, 1977, edition of the D.C. Register, and transmitted to both Houses of Congress for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired and, therefore, cites the following legislation as D. C. Law 2-27, effective October 26, 1977.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

October 26, 1977

To authorize variable periods for the issuance and expiration of licenses, registrations and permits.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT COLUMBIA,

That this act may be cited as the "Variable Licensing Periods Act of 1977."

Sec. 2. The second and third sentences of section 13 of the "District of Columbia Alcoholic Beverage Control Act", approved January 24, 1934 (48 Stat. 327; D.C. Code, sec. 25-114) are amended to read as follows:

"Every license issued under the authority of this act shall begin and end on the dates established by the Mayor. Whenever the Mayor changes a license period, the applicant for the license shall pay the appropriate proportionate amount of the annual license fee."

Sec. 3. The first sentence of paragraph 5 of section 7 of "An Act Making appropriations to provide for the expenses of the government of the District of Columbia for the fiscal year ending June thirteenth, nineteen hundred and three, and
