IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

MARCH 16, 1979

To amend certain sections of the District of Columbia Age of Majority Act to include incorporators, and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as "An Amendment to the District of Columbia Age of Majority Act".

Sec. 2. Section 6 of the "District of Columbia Age of Majority Act", effective July 22, 1976 (D.C. Law 1-75), is amended by redesignating the current section 6 as section 6 (1) and by adding new subsections (b) and (c) to read as follows:

"(b) Section 45 of the "District of Columbia Corporation Act", approved June 8, 1954 (68 Stat. 198; D.C. Code, sec. 29-921) is amended by striking "twenty-one" and inserting "eighteen" in lieu thereof.

"(c) D.C. Code, sec. 12-302(a)(1) is amended by striking "21" and inserting in lieu thereof "18".

Sec. 3. This act shall take effect upon completion of the period provided for Congressional review in section 12(c)(1) of the "District of Columbia Self-government and
