
NOTICE

D. C. LAW 3-13

"District of Columbia Surplus Property Authority Act of 1979"

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 3-50, on first and second readings, May 8, 1979 and May 22, 1979 respectively. Following the signature of the Mayor on June 8, 1979, this legislation was assigned Act No. 3-50, published in the June 15, 1979, edition of the D.C. Register, (Vol. 25 page 10563) and transmitted to Congress on June 13, 1979 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and, therefore, cites the following legislation as D.C. Law 3-13, effective August 1, 1979.

D.C. ACT 3-50

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUN 08 1979


To authorize the Mayor to promulgate rules and regulations relating to surplus property.


BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Surplus Property Authority Act of 1979".

Sec. 2. Section 2 of an Act To authorize the establishment of an educational agency for surplus property within the government of the District of Columbia, and for other purposes, approved August 16, 1950 (54 Stat. 450; D.C. Code, sec. 31-1302) is amended by striking the words: "Commissioners are" and inserting in lieu thereof the words "Mayor is".

Sec. 3. This act shall take effect as provided for acts of the Council of the District of Columbia in section 502(c) of the District of Columbia Self-Government and Governmental Reorganization Act.
