D. C. LAW 3-15

"Advisory Neighborhood Commissioners' Term of Office
Act of 1979"

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 3-26, on first and second readings, May 8, 1979 and May 22, 1979 respectively. Following the signature of the Mayor on June 18, 1979, this legislation was assigned Act No. 3-55, published in the June 29, 1979, edition of the D.C. Register, (Vol. 25 page 11003) and transmitted to Congress on June 21, 1979 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and, therefore, cites the following legislation as D.C. Law 3-15, effective September 8, 1979.

D.C. ACT 3-55

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUN 18 1979

To amend the Advisory Neighborhood Councils Act of 1975 by eliminating the two-term limitation of service for Advisory Neighborhood Commissioners.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,


That this act may be cited as the "Advisory Neighborhood Commissioners' Term of Office Act of 1979".

Sec. 2. Section 3(c) of the Advisory Neighborhood Councils Act of 1975, effective October 10, 1975 (D.C. Law 1-21; D.C. Code, sec. 1-171e(c)) is amended as follows:


(a) by striking out "two (2)" after the word "than" in line two and inserting "three (3)" in lieu thereof; and

(b) by striking out "two (2)" after the word "the" in line six and inserting "three (3)" in lieu thereof.

Sec. 3. This act shall take effect as provided for acts of the Council of the District of Columbia in section 502(c) of the District of Columbia Self-Government and Governmental Reorganization Act.
