D. C. LAW 3-28

"District of Columbia Consumer Lay Away Plan Service Charge
Amendments Act of 1979"

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 3-117, on first and second readings, June 19, 1979 and July 3, 1979 respectively. Following the signature of the Mayor on August 1, 1979, this legislation was assigned Act No. 3-77, published in the August 10, 1979, edition of the D.C. Register, (Vol. 26 page 676) and transmitted to Congress on Ausust 7, 1979 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and, therefore, cites the following legislation as D.C. Law 3-28, effective October 18, 1979.

To amend the Consumer Lay Away Plan Act of 1978 regarding service charges.

That this act may be cited as the "District of Columbia Consumer Lay Away Plan Service Charge Amendments Act of 1979".

- Sec. 2. Section 28-3813 of The D.C. Code (as added by section 2 of the District of Columbia Consumer Lay 4way Plan Act of 1973, effective October 5, 1978 (D.C. Law 2-115)) is amended as follows:
- (a) subsection (a) is amended by adding a new paragraph 3 to read as follows:
 - "(3) 'service charge' means a one time charge, not to exceed one dollar (\$1.00) on any lay away plan, to cover the administrative costs associated with such lay away plan: PROVIDED, That the one dollar (\$1.00) service charge shall cover all lay away

plan transactions between the retailer and a single consumer occurring in the same business day.":

- (b) by deleting under subsection (f) after the alphabet "(d)" the word "and", and inserting in lieu thereof a comma (,) and adding "and (j)" after the alphabet "(g)"; and
 - (c) by adding a new subsection (j) to read as follows: "(j) the seller is allowed to charge the buyer a service charge, which is not to exceed one dollar (51.00), for goods purchased under a lay away plan, to cover the administrative costs associated with such lay away plan: PROVIDED. That the one dollar (51.00) service charge shall cover all lay away plan transactions between the retailer and a single consumer occurring in the same business day.".

Sec. 3. This act shall take effect as provided for acts of the Council of the District of Columbia in section 502(c)(l) of the District of Columbia Self-Government and Governmental Reorganization Act.
