D. C. LAW 3-34

"People's Counsel Authorization Act of 1979"

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 3-70 on first and second readings, July 17, 1979 and July 31, 1979 respectively. Following the signature of the Mayor on August 31, 1979, this legislation was assigned Act No. 3-100, published in the September 7, 1979, edition of the D.C. Register, (Vol. 26 page 1119) and transmitted to Congress on September 7, 1979 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and, therefore, cites this enactment as D.C. Law 3-34 effective October 20, 1979.

To increase the authorization of appropriations for the Office of the People's Counsel of the District of Columbia.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "People's Counsel Authorization Act of 1979".


Sec. 2. Section 3 of An Act to provide a People's Counsel for the Public Service Commission in the District of Columbia, and for other purposes, adopted January 2, 1975 (88 Stat. 1977; D.C. Code, sec. 43-205a), is amended to read as follows:

"Sec. 3. There are authorized to be appropriated, to carry out the purposes of this Act, such sums as may be necessary for fiscal year 1980 and for each fiscal year thereafter."


Sec. 3. This act shall take effect as provided for acts of the Council of the District of Columbia in section
