#### D.C. LAW 3-83

"District of Columbia Educational Institution Licensure Regulations Adoption Act of 1980".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 3-259, on first and second readings, May 20, 1980 and June 3, 1980, respectively. Following the signature of the Mayor on June 20, 1980, this legislation was assigned Act No. 3-200, published in the July 4, 1980, edition of the D.C. Register, (Vol. 27 page 2894) and transmitted to Congress on June 26, 1980 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and, therefore, cites this enactment as D.C. Law 3-83 effective September 6, 1980.

# D.C. ACT 3 - 200

IN THE COUNCIL OF THE COUNCIL OF THE DISTRICT OF COLUMBIA

## JUN 2 0 1980

To amend the Educational Licensure Commission Act of 1975, to adopt regulations for the licensing of institutions which confer degrees.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA.

That this act may be cited as the "District of

Columbia Educational Institution Licensure

Regulations Adoption Act of 1980".

Sec. 2. Section 5(a) of the Educational Licensure Commission Act of 1976, effective April 5. 1977 (D.C. Law 1-104; D.C. Code, sec. 31-2006(a)) is amended to read as follows:

CODIFICATION D.C.Code, sec. 31-2006

"(a) The Commission shall utilize the regulation of the Board of Higher Education entitled 'Regulations Relating to the Licensing of Institutions Which Confer Degrees', issued July 1, 1970, until such time as the Commission wishes to amend this regulation. Any proposed

amendments to the regulation issued by the Commission shall be submitted by the Chairperson to the Council of the District of Columbia. Such amendments shall become effective at the end of a sixty (60) - day period beginning on the date of transmittal. unless during such period the Council of the District of Columbia disapproves such amendments in whole or in part by act.".

Sec. 3. This act shall take affect after a thirty (30) day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 502(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-147(c)(1)).
