Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-407 on first and second readings, March 9, 1982 and March 23, 1982, respectively. Following the signature of the Mayor on April 12, 1982, this legislation was assigned Act No. 4-176, published in the April 23, 1982 edition of the D.C. Register, (Vol. 29 page 1695) and transmitted to Congress on Aril 20, 1982 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-113, effective June 4, 1982.


BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
