
NOTICE

D.C. LAW 4-113

"District of Columbia Government Organizational Structure Act of 1982".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-407 on first and second readings, March 9, 1982 and March 23, 1982, respectively. Following the signature of the Mayor on April 12, 1982, this legislation was assigned Act No. 4-176, published in the April 23, 1982 edition of the D.C. Register, (Vol. 29 page 1695) and transmitted to Congress on April 20, 1982 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-113, effective June 4, 1982.

D.C. ACT 4-176

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

APR 12 1982

To adopt the official organizational structure of the District of Columbia government, and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Government Organizational Structure Act of 1982".

Sec. 2. Pursuant to section 7 of the Governmental Reorganization Procedures Act of 1981, effective October 17, 1981 (D.C. Law 4-42; D.C. Code, sec. 1-299.6) the organizational structure which follows is adopted as the official organizational structure of the District of Columbia government:





Sec. 4. This act shall take effect after a thirty (30)-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C.
