"Extension of the Moratorium on Retail Service Station Conversions Act of 1981".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-217 on first and second readings, June 30, 1981 and July 14, 1981, respectively. Following the signature of the Mayor on August 6, 1981, this legislation was assigned Act No. 4-80, published in the October 2, 1981 edition of the D.C. Register, (Vol. 28 page 4269) and transmitted to Congress on September 9, 1981 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-45, effective .

To amend the Retail Service Station Act of 1976 to extend the moratorium on the conversion of full service retail service stations to limited service retail service stations. and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA.

That this act may be cited as the "Extension of
the Moratorium on Retail Service Station

Conversions Act of 1981".

Sec. 2. Section 5-301 of the Retail Service Station Act of 1975, effective April 19, 1977 (D.C. Law 1-123; D.C. Code, sec. 10-231) is amended as follows:

- (a) Subsections (b) + (c) + and (e) (4) are amended by striking the phrase "October 1 + 1981" and inserting the phrase "October 1 + 1984" in lieu thereof.
- (b) The first sentence of subsection (d) is amended to read as follows: "(d) Based on the

recommendation of the Gas Station Advisory Board

(nereafter referred to as the "Board"). the Mayor

may grant exemptions to the prohibitions contained

in subsections (b) and (c) above.".

Sec.3. This act shall take effect after a thirty (30)-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-147(c)(1)).
