
NOTICE

D.C. LAW 4-48

"Closing of a Portion of a North-South Public Alley in Square 830 and Council of the District of Columbia Central Staff Employee Personnel Appeal Rules Authorization Act of 1981".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-176 on first and second readings, June 30, 1981 and July 14, 1981, respectively. Following the signature of the Mayor on August 6, 1981, this legislation was assigned Act No. 4-83, published in the October 2, 1981 edition of the D.C. Register, (Vol. 28 page 4276) and transmitted to Congress on September 9, 1981 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-48, effective October 24, 1981.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To order the closing of a portion of a north-south public alley abutting lots 66 and 810 in Square 830, bounded by L Street, N.E., K Street, N.E., 5th Street, N.E., and 6th Street, N.E. (S.O. 79-375) (Ward 2); and to authorize the issuance of Council central staff employee personnel appeal rules.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Closing of a Portion of a North-South Public Alley in Square 830 and Council of the District of Columbia Central Staff Employee Personnel Appeal Rules Authorization Act of 1981".

Sec. 2. The Council of the District of Columbia finds that:

(a) A public hearing was held on December 18, 1980, concerning the proposed closing of a portion of a north-south public alley abutting lots 66 and 810 in Square 830, bounded by L Street, N.E., K Street, N.E., 5th Street N.E., and 6th Street, N.E., as shown on a plat filed in the Office of

the Surveyor of the District of Columbia (S.O. 79-375).

(b) The proposed closing was referred to the National Capital Planning Commission for its recommendation.

(c) The portion of the alley referred to in subsection (a) should be closed.

Sec. 3. Pursuant to section 1 of The Street Readjustment Act of the District of Columbia, approved December 15, 1932 (47 Stat. 747; D.C. Code, sec. 7-401) the portion of the north-south public alley in Square 830, as shown on the plat filed in the Office of the Surveyor of the District of Columbia (S.O. 79-375) is ordered closed, with the title to the land to revert, without cost, to the owners of the abutting property.

Sec. 4. In accordance with the procedures set forth in section 4 of The Street Readjustment Act of the District of Columbia, approved December 15, 1932 (47 Stat. 749; D.C. Code, sec. 7-404), and immediately after the effective date of the Closing of a Portion of a North-South Public Alley in Square 830 Act of 1981 ("act"), the Surveyor of

the District of Columbia shall publish public notice of this act and shall send a notice to each of the owners of the abutting property that this act has taken effect.

Sec. 5. If no objection is made in writing by any interested party within thirty (30) days after the Surveyor of the District of Columbia has fulfilled the requirements of section 4, the Surveyor of the District of Columbia shall record in the Office of the Surveyor of the District of Columbia a copy of this act and the appropriate plat or plats.


Sec. 6. The officers of the Council of the District of Columbia may issue rules, subject to approval by the Council of the District of Columbia, concerning review of central staff employee personnel appeals as mandated in section 604(a) of the District of Columbia Government Comprehensive Merit Personnel Act of 1978, effective March 3, 1979 (D.C. Law 2-139; D.C. Code, sec. 1-336.4(a)).

Sec. 7. The Secretary to the Council of the District of Columbia shall transmit a certified copy of this act, upon its effective date, to the



Sec. 8. This act shall take effect after a
thirty (30)-day period of Congressional review
following approval by the Mayor (or in the event
of veto by the Mayor, action by the Council of the
District of Columbia to override the veto) as
provided in section 602(c)(1) of the District of
Columbia Self-Government and Governmental
Reorganization Act, approved December 24, 1973 (87
Stat. 813; D.C. Code, sec. 1-147(c)(1)).
