D.C. LAW 4-59

"Antique Slot Machine Act of 1981"

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-129 on first and second readings, September 29, 1981 and October 13, 1981, respectively. Following the signature of the Mayor on October 30, 1981, this legislation was assigned Act No. 4-105, published in the November 6, 1981 edition of the D.C. Register, (Vol. 28 page 4766) and transmitted to Congress on November 2, 1981 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-59, effective January 26, 1982.

To allow the private collection of slot machines which were manufactured prior to 1952 which are not used for gambling purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Antique Slot Machine Act of 1981".

Sec. 2. Section 865 of An Act To establish a code of law for the District of Columbia, approved March 3, 1901 (31 Stat. 1330; D.C. Code, sec. 22-1504) is amended by adding to the end thereof the following sentences:

"For the purposes of this section, the term 'gambling device' shall not include slot machines manufactured before 1952, intended for exhibition or private use by the owner, and not used for gambling purposes. The term 'slot machine' means a mechanical device, an essential part of which is a drum or reel which bears an insignia and which when operated may deliver, as a result of the application of an element of chance, a token, money, or property, or by operation of which a person may become entitled to receive, as a result of this application of an element of chance, a token, money, or property."

Sec. 3. This act shall take effect after a period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(2) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-147(c)(2)).
