#### D.C. LAW 4-7

"District of Columbia Government Comprehensive Merit Personnel Act Compensation Setting, Grievence and Adverse Action Reform, and Tax Waiver Amendments of 1981".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-38 on first and second readings, March 10, 1981 and March 24, 1981, respectively. Following the signature of the Mayor on April 9, 1981, this legislation was assigned Act No. 4-18, published in the April 17, 1981 edition of the D.C. Register, (Vol. 28 page 1672) and transmitted to Congress on April 13, 1981 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-7, effective June 11, 1981.

## APR 9 1981

To amend the District of Columbia Government Comprenensive Merit Personnel Act of 1978 to establish pay limitations on salaries for District of Columbia employees for fiscal year 1981 and clarify provisions relating to adverse actions and grievances of certain employees of the Council of the District of Columbia, and to amend the District of Columbia Income and Franchise Tax Act of 1947 to allow for tax deductions for compensation waived by District of Columbia government employees.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA.

That this act may be cited as the "District of

Columbia Government Comprenensive Merit Personnel

Act Compensation Setting. Grievence and Adverse

Action Reform, and Tax Waiver Amendments of 1981".

Sec. 2. Title XI of the District of Columbia Government Comprehensive Merit Personnel Act of 1978. effective March 3. 1979 (D.C. Law 2-139; D.C. Code sec. 1-341.1 et seq.) is amended by adding the following new section at the end thereof to read as follows:

"Sec. 1117. Pay Limitations Under Other Laws.

\*Notwithstanding the provisions of section 9 of An Act To establish a District of Columbia Armory Board and for other purposes, approved June 4. 1948 (62 Stat. 342; D.C. Code. sec. 2-1709). section B(a) of the District of Columbia Stadium Act of 1957, approved September 7, 1957 (7) Stat. 521; D.C. Code, sec. 2-1726 (a)), section 305 of the District of Columbia Court Reform and Criminal Procedures Act of 1970, approved July 29, 1970 (84 Stat. 656; D.C. Code, sec. 2-2225), or D.C. Code. sec. 23-1306. or any other provision of law. no employee of the District of Columbia government shall be authorized to receive pay in excess of that provided for in this title, and any such provision of law that is inconsistent with this section shall be deemed superseded to the extent of such inconsistency.".

Sec. 3. Sec. 3(a)(8) of Title III of the District of Columbia Income and Franchise Tax Act of 1947, approved July 16, 1947 (61 Stat. 337; D.C. Code, sec. 47-1557b(a)(8)) is amended as follows:

(a) by inserting immediately following the phrase "to or for the use of" the phrase "the

D.C.Code, sec. 47-1557b District of Columbia, but only if the contribution a qift is made exclusively for public purposes, or"; and

(b) by adding the following sentence at the end thereof to read as follows:

"For purposes of this section the words

"actually paid", when used with reference to the
District of Columbia, includes compensation waived
under section 1116 of the District of Columbia
Government Comprehensive Merit Personnel Act of
1978.".

Sec. 4. Section 905 of the District of Columbia Government Comprenensive Merit Personnel Act of 1978, effective March 3. 1979 (D.C. Law 2-139; D.C. Code, sec. 1-339.5) is amended by striking the period at the end of the last sentence and inserting the following proviso to read as follows: ": EXCEPT. That persons amployed by the Council of the District of Columbia by personnel authorities identified in section 400(0)(3)(5) may have their amployment relationship terminated by the Memper or chairperson of a Committee of the Council of the District of Columbia employing them without

further review by way of grievance or adverse action administrative appeals.\*\*•

Sec. 5. (a) This act shall take effect after a thirty (30)-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-147(c)).

(b) The provisions of section 3 shall apply to taxable years beginning after December 31.
