

D.C. LAW 4-87

"Redistricting Procedure Act of 1981".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-181 on first and second readings, November 24, 1981 and December 8, 1981, respectively. This legislation was deemed approved without the signature of the Mayor on January 19, 1982, pursuant to Section 404(e) of "the Act", and was assigned Act No. 4-141, published in the January 29, 1982 edition of the D.C. Register, (Vol. 29 page 433) and transmitted to Congress on January 25, 1982 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-87, effective March 16, 1982.

To reapportion the wards of the District of Columbia; to establish the procedure and the date by which decennial redistricting of Advisory Neighborhood Commission single-member districts, Advisory Neighborhood Commission areas, and election wards must occur; to conform to the greatest extent possible the boundaries of single-member districts and election wards with the boundaries of census tracts; and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Redistricting Procedure Act of 1981".

Sec. 2. Establishment of the Commission on the Census.

(a) The Commission on the Census ("Commission") is established as an agency of the District of Columbia government ("District government"). This Commission shall advise the Council of the District of Columbia ("Council"), the Mayor of the District of Columbia ("Mayor"), the District of Columbia Board of Elections and Ethics, and the public on matters concerning the decennial census and the redistricting of the boundaries of the Advisory Neighborhood Commission

single-member districts, Advisory Neighborhood Commission areas, and, following the decennial census of 1990, election wards in the District of Columbia.

(b) The Commission shall consist of twenty-five (25) members. Seventeen (17) of the Commission members shall be public members. Each of the thirteen (13) Members of the Council or their respective designee shall serve as a public member to the Commission. The Mayor shall appoint four (4) public members to the Commission. Appointments of public members to the Commission shall be effective upon the publication of notice of each such appointment in the District of Columbia Register. Eight (8) of the Commission members shall be the following non-voting exofficio members: the Chief Demographer, the Chief Statistician, the Citizen Participation Coordinator, and the Senior Research Analyst of the Office of the Assistant City Administrator for Planning and Development; the Chairman (or the Chairman's designated representative) of the Board of Elections and Ethics; the Directors (or their designated representatives) of the Department of Housing and Community Development, the Department of Human Services, and the Department of Transportation.

(c) Each public member of the Commission shall be a resident of the District of Columbia.

(d) The Commission shall develop its own rules of procedure. The Commission shall meet at least twice a year. All meetings shall be open to the public and prior notice of all meetings shall be provided in the District of Columbia Register.

(e) The Chairman of the Council shall select the Chairperson of the Commission.

(f) The Chief Statistician of the Office of the Assistant City Administrator for Planning and Development shall act as the liaison between the Commission and the United States Bureau of the Census.

(g) All members shall serve without compensation, but expenses incurred by the Commission as a whole, or by its individual members, when authorized by the Chairperson, will become an obligation against appropriated District of Columbia and federal funds authorized for that purpose.

(h) The Office of the Assistant City Administrator for Planning and Development shall act as the secretariat to the Commission by providing such information and technical or clerical assistance which are reasonably necessary for the Commission to perform its functions. Such

appropriations as may be necessary are authorized to carry out the purposes of this subsection.

Sec. 3. Functions of the Commission.

(a) The Commission shall:

(1) draw boundary lines of census tracts in the District of Columbia to be submitted to the United States Bureau of the Census for approval as part of the official decennial census report;

(2) submit alternative plans to the Council for the adjustment of the boundaries of the election wards as a result of population shifts and changes; such alternative recommendations shall be submitted to the Council not later than one hundred-twenty (120) calendar days following transmittal to the Commission of that census tract data from the decennial census of 1990 and each decennial census thereafter required for redistricting;

(3) submit alternative plans to the Council for the adjustment of the boundaries of the Advisory Neighborhood Commission single-member districts and the Advisory Neighborhood Commission areas within one (1) year from the date that the Council adopts an act defining the boundaries of election wards;

(4) make recommendations to the District government regarding census tract identification

and tabulation in District government agency files, and regarding other uses of census geography and data; and

(5) review and submit to the Mayor and the Council an annual report including an analysis of the activities of the Commission.

(b) The Commission may make any reasonable request to the Mayor, the Council, or District government agencies for information or technical assistance necessary to aid the Commission in the discharge of its responsibilities.

(c) The Commission shall consider the following criteria, as well as any other criteria that the Commission deems appropriate, for proposed decennial adjustments in the boundaries of Advisory Neighborhood Commission single-member districts, Advisory Neighborhood Commission areas, and election wards:

(1) Each single-member district shall have a population of approximately two thousand (2,000) people;

(2) The boundaries of each single-member district shall conform to the greatest extent possible with the boundaries of the census tracts which are established by the United States Bureau of the Census;

(3) The boundaries of each Advisory

Neighborhood Commission area shall conform to the greatest extent possible with the boundaries of the census tracts which are established by the United States Bureau of the Census;

(4) To the greatest extent possible, each Advisory Neighborhood Commission area shall be located entirely within only one (1) election ward; and

(5) The population size of each of the eight (8) compact and contiguous wards shall be approximately equal.

Sec. 4. Adoption of Election Ward Boundaries Effective April 1, 1982.

The Council adopts the following election ward boundaries to be effective April 1, 1982, and to be used in all elections held after May 1, 1982, in the District of Columbia:

Twenty-Eighth Street, N.W.; thence north along said Twenty-Eighth Street, N.W., to R Street, N.W.; thence west along said R Street, N.W., to Thirty-Second Street, N.W.; thence south along said Thirty-Second Street, N.W., to Q Street, N.W.; thence west along said Q Street, N.W., to Wisconsin Avenue, N.W.; thence in a northwesterly direction along said Wisconsin Avenue, N.W., to Thirty-Fifth Street, N.W.; thence south along said Thirty-Fifth Street, N.W., to Reservoir Road, N.W.; thence west along said Reservoir Road, N.W., to the westerly boundary line of Georgetown University (the easterly boundary line of Glover-Archbold Park); thence in a southerly direction along said westerly boundary line of Georgetown University and an extension of such boundary line to the Commonwealth of Virginia-District of Columbia boundary line at the Commonwealth of Virginia shore of the Potomac River; thence in a northwesterly direction along said Commonwealth of Virginia-District of Columbia boundary line where it follows the Commonwealth of Virginia shore of the Potomac River to the western corner of the District of Columbia; thence in a northeasterly direction along the State of Maryland-District of Columbia boundary line to the point of beginning at its intersection with the

center line of Rock Creek.

WARD IV

Starting at the intersection of the center line of Rock Creek with the State of Maryland-District of Columbia boundary line; thence in a southerly direction along Rock Creek to the intersection of the center line of Rock Creek and the extension of the center line of Piney Branch Parkway, N.W.; thence in an easterly direction along said Piney Branch Parkway, N.W., to Sixteenth Street, N.W.; thence south along said Sixteenth Street, N.W., to Spring Road, N.W.; thence in an easterly direction along said Spring Road, N.W., to New Hampshire Avenue, N.W.; thence in a northeasterly direction along said New Hampshire Avenue, N.W., to Rock Creek Church Road, N.W.; thence in an easterly direction along said Rock Creek Church Road, N.W., to Park Place, N.W.; thence in a southerly direction along said Park Place, N.W., to Michigan Avenue, N.W.; thence in an easterly direction along said Michigan Avenue, N.W., and N.E., to Harewood Road, N.E.; thence in a northerly direction along said Harewood Road, N.E., to Taylor Street, N.E.; thence east along said Taylor Street, N.E., to Hawaii Avenue, N.E.;

along said First Street, N.W., to Bryant Street, N.W.; thence in a westerly direction along said Bryant Street, N.W., to Second Street, N.W.; thence south on said Second Street, N.W., to Florida Avenue, N.W.; thence in a westerly direction along said Florida Avenue, N.W., to New Jersey Avenue, N.W.; thence in a southerly direction along said New Jersey Avenue, N.W., to New York Avenue, N.W.; thence in an easterly direction along said New York Avenue, N.W., and N.E., to Florida Avenue, N.E.; thence in an easterly direction along said Florida Avenue, N.E., to Benning Road, N.E.; thence in an easterly direction along said Benning Road, N.E., to the center line of the Anacostia River; thence in a northerly direction along the Anacostia River to the intersection of its center line with the State of Maryland-District of Columbia boundary line; thence in a northwesterly direction along said boundary line to Kennedy Street, N.E.; thence in a westerly direction along said Kennedy Street, N.E., to South Dakota Avenue, N.E.; thence in a northwesterly direction along said South Dakota Avenue, N.E., to Riggs Road, N.E.; thence in a westerly direction along said Riggs Road, N.E., to the center line of the railroad right of way; thence in a southerly direction along the center

Starting at the intersection of the State of Maryland-District of Columbia boundary line and the center line of the Anacostia River; thence in a southerly direction along the center line of said Anacostia River to East Capitol Street; thence east along said East Capitol Street to Minnesota Avenue, S.E.; thence in a southerly direction along said Minnesota Avenue, S.E., to Twenty-Fifth Street, S.E.; thence south along said Twenty-Fifth Street, S.E., to Naylor Road, S.E.; thence in a southerly direction along said Naylor Road, S.E., to Good Hope Road, S.E.; thence in a southeasterly direction along said Good Hope Road, S.E., to Naylor Road, S.E.; thence in a southeasterly direction along said Naylor Road, S.E., to the State of Maryland-District of Columbia boundary line; thence in a northeasterly direction along said State of Maryland-District of Columbia boundary line to the eastern corner of the District of Columbia; thence in a northwesterly direction along the State of Maryland-District of Columbia boundary line to the point of beginning at its intersection with the center line of the Anacostia River.

Starting at the intersection of the Commonwealth of Virginia-District of Columbia boundary line on the Commonwealth of Virginia shore of the Potomac River with the projection of the center line of the Anacostia River; thence in a northeasterly direction along the center line of said Anacostia River to the western (southbound) roadway of the Eleventh Street Bridge; thence in a southerly direction along said western (southbound) roadway of the Eleventh Street Bridge to the center line of the Baltimore and Ohio Railroad right of way; thence in a southwesterly direction along the center line of said railroad right of way to Chicago Street, S.E.; thence in a southeasterly direction along said Chicago Street, S.E., to Martin Luther King, Jr., Avenue, S.E.; thence in a southwesterly direction along said Martin Luther King, Jr., Avenue, S.E., to Morris Road, S.E.; thence in a southeasterly direction along said Morris Road, S.E., to Erie Street, S.E.; thence in an easterly direction along said Erie Street, S.E., to Fort Place, S.E.; thence in a southeasterly direction along said Fort Place, S.E., to Bruce Place, S.E.; thence in a northeasterly direction along said Bruce Place, S.E., to Reynolds Place, S.E.; thence in a southeasterly direction along said Reynolds Place,

Except where otherwise indicated, the boundary line is the center of the street.

Sec. 5. Amendments to Other Acts.

(a) Section 4 of the Advisory Neighborhood Commissions Act of 1975, effective October 10, 1975 (D.C. Law 1-21; D.C. Code, sec. 1-234) is amended to read as follows:

"(a) The Council shall, by resolution, establish single-member districts for each of the Neighborhood Commission areas in section 3. Such districts shall be established in a timely manner following the receipt of alternate plans from the Commission on the Census, established by section 2 of the Redistricting Procedure Act of 1981. Each single-member district shall have a population of approximately two thousand (2,000) people, and shall be as nearly equal as possible. The boundaries of the single-member districts shall conform to the greatest extent possible with the boundaries of the census tract which are established by the United States Bureau of the Census. Upon adoption of the resolution establishing such districts, the Council shall cause a description of the boundaries of each such district to be published in the District of Columbia Register.

"(b) The Council shall, by resolution after public hearing by the Council's Committee of the Whole, make such adjustments in the boundaries of the Advisory Neighborhood Commission single-member districts and the Advisory Neighborhood Commission areas as are necessary as a result of population shifts and changes. Such adjustments shall be made in a

timely manner following the receipt of alternative plans from the Commission on the Census, established by section 2 of the Redistricting Procedure Act of 1981. Any adjustments made less than one hundred eighty (180) days prior to a regularly scheduled election shall not be effective for that election."

(b) Section 2 of the Boundaries Act of 1975, effective December 16, 1975 (D.C. Law 1-38; D.C. Code, sec. 1-1308) is amended to read as follows:

"The Council of the District of Columbia shall divide the District of Columbia into eight compact and contiguous election wards as will provide approximately equal population within each ward. The Council shall, after receipt of the recommendations of the Commission on the Census, established by section 2 of the Redistricting Procedure Act of 1981 and public hearing, make such adjustments in the boundaries of election wards as are necessary as a result of population shifts and changes. Any adjustments made less than one hundred eighty (180) days prior to a regularly scheduled election shall not be effective for that election, or if that election is a primary election, for the general election following the primary election."



Sec. 6. No official elected from any ward or from any single-member district shall be required to forfeit his or her office solely by reason of a change in boundaries which places the residence of such official outside the ward or single-member district from which he or she was elected. Such official shall be permitted to complete his or her term of office, but in future elections he or she may be a candidate only in the ward or single-member district in which he or she resides.

Sec. 7. This act shall take effect after a thirty (30)-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
