

D.C. LAW 5-140

"District of Columbia Government Comprehensive Merit Personnel Act of 1978/Retirement Annuity Pay Reduction Exception Temporary Act of 1984".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-524 on first and second readings, October 9, 1984 and October 23, 1984, respectively. Following the signature of the Mayor on October 25, 1984, this legislation was assigned Act No. 5-198, published in the November 16, 1984 edition of the D.C. Register, (Vol. 31 page 5755) and transmitted to Congress January 7, 1985 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-140, effective March 13, 1985.

D.C. ACT 5 - 198

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

OCT 25 1984

To amend, on a temporary basis, the District of Columbia Government Comprehensive Merit Personnel Act of 1978 to provide that District government employees who receive an annuity under any retirement system of the uniformed services of the United States shall have their compensation reduced only when their income from their District government position plus their annuity exceeds the amount payable for a Grade 15 in the District Service Schedule 1.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Government Comprehensive Merit Personnel Act of 1978/Retirement Annuity Pay Reduction Exception Temporary Act of 1984".

Sec. 2. Section 1103 of the District of Columbia Government Comprehensive Merit Personnel Act of 1978, effective March 3, 1979 (D.C. Law 2-139; D.C. Code, sec. 1-612.3), is amended as follows:

(a) Subsection (b) is amended to read as follows:

"(b) The pay of an individual receiving an annuity under any federal or District government civilian retirement system selected for employment in the District government on or after the effective date of this title shall be reduced by the amount of annuity allocable to the period of employment as a reemployed annuitant."


(b) A new subsection (c) is added to read as follows:

"(c) The pay of an individual receiving an annuity under any retirement system of the uniformed services of the United States selected for employment in the District government on or after the effective date of this title shall be reduced by only that amount of the individual's salary which when added to his or her annuity exceeds the basic pay then in effect for step one of a Grade 15 of the District Service Schedule 1."


Sec. 3. (a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).

(b) This act shall expire on the 180th day after its having taken effect.
