"Martin Luther King, Jr., Birthday Holiday Conformity Act of 1984".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-322 on first and second readings, November 7, 1984 and December 4, 1984, respectively. Following the signature of the Mayor on December 10, 1984, this legislation was assigned Act No. 5-220, published in the January 4, 1985 edition of the D.C. Register, (Vol. 32 page 11) and transmitted to Congress January 8, 1985 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-155, effective March 14, 1985.

## D.C. ACT 5 - 220

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

## DEC 1 0 1984

To conform the date of the recognition of the birthday of Martin Luther King, Jr., to the day prescribed for its recognition by federal agencies pursuant to the laws of the United States.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Martin Luther King, Jr., Birthday Holiday Conformity Act of 1984".

Sec. 2. Section 1202(a) of the District of Columbia
Government Comprehensive Merit Personnel Act of 1978,
effective March 3, 1979 (D.C. Law 2-139; D.C. Code, sec.
1-613.2(a)(2)), is amended in the second paragraph by
striking the phrase "January 15th" and inserting the phrase
"the third Monday in January" in its place.

- Sec. 3. D.C. Code, section 28-2701 is amended by striking in the first sentence the phrase "the fifteenth day of January" and inserting the phrase "the third Monday in January" in its place.
- Sec. 4. (a) Except as provided in subsection (b), this act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and

Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).

(b) Sections 2 and 3 shall take effect January 1, 1986.
