D.C. LAW 5-159

"End of Session Technical Amendments Act of 1984".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-540 on first and second readings, November 20, 1984 and December 4, 1984, respectively. Following the signature of the Mayor on December 10, 1984, this legislation was assigned Act No. 5-224, published in the January 4, 1985 edition of the D.C. Register, (Vol. 32 page 30) and transmitted to Congress January 8, 1985 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-159, effective March 14, 1985.
