## D.C. LAW 5-161

"University of the District of Columbia Board of Trustees Nominating Committee Amendment Act of 1984".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-516 on first and second readings, November 20, 1984 and December 4, 1984, respectively. Following the signature of the Mayor on December 7, 1984, this legislation was assigned Act No. 5-226, published in the January 11, 1985 edition of the D.C. Register, (Vol. 32 page 158) and transmitted to Congress January 8, 1985 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-161, effective March 14, 1985.

## D.C. ACT 5 - 226

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

# DEC 0 7 1984

To amend the District of Columbia Public Postsecondary
Education Reorganization Act; to modify the domiciliary
requirement of the University of the District of
Columbia Board of Trustees Nominating Committee and
Mayoral nominees to the Board of Trustees.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "University of the
District of Columbia Board of Trustees Nominating Committee
Amendment Act of 1984".

Sec. 2. Section 202 of the District of Columbia Public Postsecondary Education Reorganization Act, effective November 1, 1975 (D.C. Law 1-36; D.C. Code, sec. 31-1512), is amended as follows:

D.C. Code, sec. 31-1512 (1985 supp.)

- (a) Subsection 202(c)(2) (D.C. Code, sec.
  31-1512(c)(2)) is amended to read as follows:
- "(2) is a resident of the District of Columbia and has maintained his or her domicile within the District of Columbia for the twelve months immediately preceding the date of his or her appointment; and";
- (b) By striking the present subsection 202(k), (D.C.Code, sec. 31-1512(k)), redesignating subsections (1) and(m) as subsections (k) and (l) respectively, and inserting a new subsection (m) to read as follows:
  - "(m) Each individual whose name is included on a list

a member of the Board of Trustees of the University of the District of Columbia shall be a resident of the District of Columbia and shall have maintained domicile in the District of Columbia for twelve months immediately preceding the date of submission of the list to the Mayor.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
