D.C. LAW 5-166

"Bistrict of Columbia General Hospital Commission Act Amendments Act of 1984".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-200 on first and second readings, December 4, 1984 and December 18, 1984, respectively. Following the signature of the Mayor on January 11, 1985, this legislation was assigned Act No. 5-231, published in the February 8, 1985 edition of the D.C. Register, (Vol. 32 page 716) and transmitted to Congress January 23, 1985 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-166, effective March 15, 1985.

To amend the D.C. General Hospital Commission Act to grant the D.C. General Hospital Commission authority to enter into contracts for capital construction projects.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "D.C. General Hospital Commission Act Amendments Act of 1984".

- Sec. 2. Section 210(8) of the D.C. General Hospital Commission Act, effective May 13, 1977 (D.C. Law 1-134; D.C. Code, sec. 32-220(8)), is amended to read as follows:
- all of its purposes, including arrangements for certain services to be provided by other hospitals if economy or sophistication of required services so dictate, and including contracts for capital construction projects for which funds have been authorized and made available to construct, maintain, repair, improve or modify Commission facilities and to plan, design, and implement capital construction projects: Provided, That 'Commission facilities' as used in this paragraph means health care facilities or other facilities owned by or under the jurisdiction of the Commission but does not include sidewalks or streets that are public ways or any sewer or

water mains; and Provided, Further, that the Commission shall exercise the authority granted by this paragraph only pursuant to procurement rules which the Commission shall promulgate that conform to all District of Columbia and federal laws regarding procurements by the District of Columbia government.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of a veto by the Mayor, action by the Council of the District of Columbia to override the veto), as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,
