D.C. LAW 5-196

"Cnild Abuse Reform Act of 1984".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-426 on first and second readings, September 12, 1984, and October 23, 1984, respectively. Following the signature of the Mayor on November 8, 1984, this legislation was assigned Act No. 5-204, published in the November 30, 1984, edition of the D.C. Register, (Vol. 31 page 5977) and transmitted to Congress on January 8, 1985 for a 60-day review, in accordance with Section 602 (c)(2) of the Act.

The Council of the District of Columbia hereby gives notice that the 60-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-196, effective May 3, 1985.

D.C. ACT 5 - 204

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

NOV - 8 1984

To abolish the requirement for independent corroboration of the testimony of a child victim of any crime listed in title 22 of the D.C. Code.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Child Abuse Reform Act of 1984".

- Sec. 2. Title 23 of the District of Columbia is amended as follows:
- (a) The chapter table of contents for chapter 1 is amended by adding the words:
- "23-114. Corroboration of a child witness' testimony not required."; and
- (b) A new section 23-114 is added to read as follows: "Section 23-114. Corroboration of a child witness' testimony not required.

"For purposes of prosecutions brought under title 22 of the D.C. Code, independent corroboration of the testimony of a child victim is not required to warrant a conviction.".

Sec. 3. This act shall take effect after a 60-day period of Congressional review following approval by the Mayor (or in the event of a veto by the Mayor, action by the Council of the District of Columbia to override the veto) as
