"Advisory Neighborhood Commission Funding Threshold Act of 1983".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-107 on first and second readings, June 7, 1983 and June 21, 1983, respectively. Following the signature of the Mayor on July 6, 1983, this legislation was assigned Act No. 5-47, published in the July 22, 1983 edition of the <u>D.C. Register</u>, (Vol. 30 page 3654) and transmitted to Congress July 11, 1983 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-26, effective September 27, 1983.

To amend the provisions of title VII of the District of Columbia Self-Government and Governmental Reorganization Act.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "Advisory Neighborhood
Commission Funding Threshold Act of 1983".

Sec. 2. Section 738(e) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 825; D.C. Code, sec. 1-251(e)), is amended to read as follows:

"(e) In order to pay the expenses of the advisory neighborhood commissions, enable them to employ such staff as may be necessary, and to conduct programs for the welfare of the people in a neighborhood commission area, the District Government shall allot funds to the advisory neighborhood commissions out of the general revenues of the District in an amount which is not less than the amount provided in the prior fiscal year, and in no event, an amount less than that provided in the fiscal year ending September 30, 1983. The funding apportioned to each advisory neighborhood commission shall bear the same ratio to the full sum alloted as the population of the neighborhood bears to the population of the District. The

Council may authorize additional methods of financing advisory neighborhood commissions.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(l) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(l)).
