### D.C. LAW 5-66

"Department of Transportation Hearing Examiner Temporary Act of 1983".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-350 on first and second readings, December 20, 1983 and January 3, 1984, respectively. Following the signature of the Mayor on January 11, 1984, this legislation was assigned Act No. 5-99, published in the January 20, 1984 edition of the D.C. Register, (Vol. 31 page 212) and transmitted to Congress January 23, 1984 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-66, effective March 14, 1984.

To amend, on a temporary basis, the District of Columbia Traffic Adjudication Act of 1978 in order to extend the terms of hearing examiners employed by the Department of Transportation of the District of Columbia; and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,

That this act may be cited as the "Department of

Transportation Hearing Examiner Temporary Act of 1983".

- Sec. 2. Section 104(a) of the District of Columbia

  Traffic Adjudication Act of 1978, effective September 12,

  1978 (D.C. Law 2-104; D.C. Code, sec. 40-604(a)), is amended

  by:
- (1) Designating subsection (a) as subsection (a)(1);and
  - (2) Inserting a new paragraph (2) to read as follows:
- "(2) Notwithstanding subsection (a)(1), hearing examiners appointed prior to the effective date of the Department of Transportation Hearing Examiner Temporary Act of 1983 may continue to serve until the expiration of their five (5) year terms or until the expiration of the Department of Transportation Hearing Examiner Temporary Act of 1983, whichever is later.".
- Sec. 3. (a) This act shall take effect after a 30-day period of Congressional review following approval by the

(b) This act shall expire on the 180th day from the date of its having taken effect or on the day that the Department of Transportation Hearing Examiner Act of 1983 takes effect, whichever occurs 1st.
