"Reprogramming Policy Act of 1980/Definitions and Process Amendments Act of 1983".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-237 on first and second readings, January 3, 1984 and January 17, 1984, respectively. Following the signature of the Mayor on February 7, 1984, this legislation was assigned Act No. 5-105, published in the February 17, 1984 edition of the D.C. Register, (Vol. 31 page 628) and transmitted to Congress February 10, 1984 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-70, effective April 3, 1984.

To amend the Reprogramming Policy Act of 1980 to redefine and add certain terms; to provide specific guidance to the Mayor in the discharge of the Mayor's responsibilities; and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Reprogramming Policy Act of 1980/Definitions and Process Amendments Act of 1983".

- Sec. 2. The Reprogramming Policy Act of 1980, effective September 16, 1980 (D.C. Law 3-100; D.C. Code, sec. 47-361 et seq.), is amended as follows:
- (a) Section 2 (D.C. Code, sec. 47-361) is amended as follows:
- (1) Paragraph (7) is amended by striking the period at the end thereof and inserting the phrase "or in the appropriated budget authority." in lieu thereof; and
- (2) Paragraph (8) is amended by striking the period at the end thereof and inserting the phrase "or in the appropriated budget authority." in lieu thereof; and
- (3) A new paragraph (2a) is added to read as follows:
- "(2a) 'Budget category' includes control centers and responsibility centers."; and
 - (b) Section 4 (D.C. Code, sec. 47-363) is amended by

adding a new subsection (e-1) to read as follows:

"(e-1) Reprogrammings transmitted to the Council pursuant to subsections (a), (b), (c), and (e) of this section shall include a specific listing of responsibility centers and control centers, or both, from which funds are being reduced and a specific listing of responsibility centers and control centers, or both, to which funds are being added. Each separate reprogramming request shall be for the total net sum of zero dollars.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
