"Department of Transportation Hearing Examiner Act of 1984".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-220 on first and second readings, February 28, 1984 and March 13, 1984, respectively. Following the signature of the Mayor on March 29, 1984, this legislation was assigned Act No. 5-119, published in the April 13, 1984 edition of the D.C. Register, (Vol. 31 page 1683) and transmitted to Congress April 2, 1984 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-83, effective May 22, 1984.

To permit the reappointment of current hearing examiners of the Department of Transportation of the District of Columbia; and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Department of Transportation Hearing Examiner Act of 1983".

Sec. 2. Section 104(a) of the District of Columbia D.C. Code, Traffic Adjudication Act of 1978, effective September 12, 1978 (D.C. Law 2-104; D.C. Code, sec. 40-604(a)), is amended by striking the "." at the end and inserting in its place the following:

sec. 40-604 Note, D.C. Co sec. 1-608.1 (1981 ed.)

", except that the Chief Hearing Examiner and each hearing examiner serving a term within the Bureau of Traffic Adjudication on the effective date of the Department of Transportation Hearing Examiners Act of 1983 shall be considered to be eligible for a single reappointment for an additional period of two (2) years under the terms of this section. The Chief Hearing Examiner and each hearing examiner appointed pursuant to this section shall serve, during their terms, as career service employees in accordance with section 801 of the District of Columbia Government Comprehensive Merit Personnel Act of 1978,

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(l) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(l)).
