D.C. LAW 5-85

"Office of Cable Television Amendment Act of 1984".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-357 on first and second readings, March 13, 1984 and March 27, 1984, respectively. Following the signature of the Mayor on April 5, 1984, this legislation was assigned Act No. 5-123, published in the April 20, 1984 edition of the D.C. Register, (Vol. 31 page 1864) and transmitted to Congress April 9, 1984 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-85, effective June 1, 1984.

# DC ACT 5-123

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

## APR 05 1984

To amend the Cable Television Communications Act of 1981 to place the Office of Cable Television within the executive branch of the District of Columbia government; and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Office of Cable Television Amendment Act of 1984".

- Sec. 2. The Cable Television Communications Act of 1981, effective August 21, 1982 (D.C. Law 4-142; D.C. Code, sec. 43-1801 et seq.), is amended as follows:
- (a) Section 6 (D.C. Code, sec. 43-1805) is amended to read as follows:

"Sec. 6. Office of Cable Television.

D.C. Code, set 43-1805 (1983 supp.)

"There is established within the executive branch of the District of Columbia government as a subordinate agency an Office of Cable Television which shall be administered by an Executive Director appointed by the Mayor and confirmed by the Council. No person shall be eligible to hold the office of Executive Director who has not been a bona fide resident of the District of Columbia for at least 3 years immediately preceding his or her nomination or who has voted or claimed residence elsewhere during this period. The Executive Director shall not have, or have had within the 3

years preceding his or her nomination, any ownership, business interest, or business affiliation in or with any cable franchisee in the District of Columbia. The nomination of the first Executive Director shall be submitted to the Council for its confirmation at any time after the date upon which this section takes effect, but shall be submitted no later than June 1, 1984.".

(b) Section 3(12) (D.C. Code, sec. 43-1802(12)) is amended by striking the word "independent" appearing therein.

(d) Section 8 (D.C. Code, sec. 43-1807) is amended by striking the phrase "as may be assigned to him or her by the Council, or".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec.
