D.C. LAW 6-1

"District of Columbia Statehood Constitutional Convention Initiative of 1979 Amendments Act of 1985".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-59 on first and second readings, January 29, 1985 and February 12, 1985, respectively. Following the signature of the Mayor on February 28, 1985, this legislation was assigned Act No. 6-11, published in the March 15, 1985 edition of the D.C. Register, (Vol. 32 page 1475) and transmitted to Congress March 4, 1985 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-1, effective April 23, 1985.

D.C. ACT 6-11

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

FEB 28 1985

To amend the District of Columbia Statehood Constitutional Convention Initiative of 1979 to postpone the date of the 1st election for the Office of Senator and Representative.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Statehood Constitutional Convention Initiative of 1979 Amendments Act of 1985".

Sec. 2. Section 4(d) of the District of Columbia Statehood Constitutional Convention Initiative of 1979, effective August 14, 1982 (D.C. Law 4-138; D.C. Code, sec. 1-113(d)), is amended as follows:


(a) by striking in paragraph (1) the year "1984" wherever it appears and inserting the year "1987" in its place;

(b) by striking in the second sentence of paragraph (2) the year "1987" and inserting the year "1989" in its place;


(c) by striking in the third sentence of paragraph (2) the year "1989" and inserting the year "1991" in its place; and

(d) by striking in the third sentence of paragraph (2) the year "1991" and inserting the year "1993" in its place.

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
