
NOTICE

D.C. LAW 6-117

"District of Columbia Soil and Water Conservation Act of 1982 Technical Amendment Act of 1986".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-336 on first and second readings, March 11, 1986, and March 25, 1986, respectively. Following the signature of the Mayor on April 8, 1986, this legislation was assigned Act No. 6-152, published in the April 25, 1986, edition of the D.C. Register, (Vol. 33 page 2442) and transmitted to Congress on April 11, 1986 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-117, effective May 23, 1986.

D.C. ACT 6 - 152

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

APR 08 1986

To make technical amendments to the District of Columbia Soil and Water Conservation Act of 1982.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Soil and Water Conservation Act of 1982 Technical Amendment Act of 1986".

Sec. 2. Section 5(b) of the District of Columbia Soil and Water Conservation Act of 1982, effective September 14, 1982 (D.C. Law 4-143; D.C. Code, sec. 1-2804(b)), is amended by striking the first sentence and inserting the following sentence in its place:

D.C. Code, s. 1-2804 (1987 supp.)


"Five members, at least 4 of whom shall be directors of appropriate agencies or departments of the District of Columbia government, shall be appointed by and serve at the pleasure of the Mayor."

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the

Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
