D.C. LAW 6-119

"Alcoholic Beverage Control Act Temporary Amendment Act of 1986".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-392 on first and second readings, March 11, 1986, and March 25, 1986, respectively. Following the signature of the Mayor on April 8, 1986, this legislation was assigned Act No. 6-154, published in the April 25, 1986, edition of the D.C. Register, (Vol. 33 page 2447) and transmitted to Congress on April 11, 1986 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-119, effective May 23, 1986.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To amend, on a temporary basis, the provisions of the District of Columbia Alcoholic Beverage Control Act to change the definition of restaurant.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "Alcoholic Beverage
Control Act Temporary Amendment Act of 1986".

- Sec. 2. Section 3(n) of the District of Columbia

 Alcoholic Beverage Control Act, approved January 24, 1934

 (48 Stat. 320; D.C. Code, sec. 25-103(14)), is amended by inserting a period in the first sentence after the phrase "such space is intended for use primarily as a place for preparing, cooking and serving meals", and by striking the remainder of the sentence.
- Sec. 3. Nothing in this act shall be construed as a limitation on the Alcohol Beverage Control Board ("Board") to consider claims (in addition to those regarding the preparation and service of meals) raised by interested persons concerning the granting or denial of a class C retailer's license or the renewal thereof: Provided, that

licenses issued by the Board during the effective period of the Alcoholic Beverage Control Act Temporary Amendment Act shall not extend beyond October 1, 1986.

Sec. 4(a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).

(b) This act shall expire on October 1, 1986.
