"Victims of Violent Crimes Compensation Act of 1981 Amendments Act of 1986".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-378 on first and second readings, May 27, 1986 and June 10, 1986, respectively. Following the signature of the Mayor on June 13, 1986, this legislation was assigned Act No. 6-174, published in the June 27, 1986, edition of the <u>D.C. Register</u>, (Vol. 33 page 3796) and transmitted to Congress on June 16, 1986 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-136, effective August 9, 1986.

D.C. ACT 6 - 174

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUN 1 3 1986

To amend the Victims of Violent Crimes Compensation Act of 1981 to ensure that non-residents of the District of Columbia are eligible for compensation based on the same criteria as residents of the District of Columbia, and to repeal the \$5.00 filing fee.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Victims of Violent Crimes Compensation Act of 1981 Amendments Act of 1986".

- Sec. 2. The Victims of Violent Crimes Compensation Act of 1981, effective April 6, 1982 (D.C. Law 4-100; D.C. Code, sec. 3-401 et seg.), is amended as follows:
- (a) Section 3(a)(3) (D.C. Code, sec. 3-402(a)(3)) is repealed; and

(b) Section 12(a)(2) (D.C. Code, sec. 3-411(a)(2)) is repealed.

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as
