"Home Purchase Assistance Fund Act Amendments Act of 1986".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-395 on first and second readings, June 24, 1986 and July 8, 1986, respectively. Following the signature of the Mayor on July 16, 1986, this legislation was assigned Act No. 6-193, published in the August 8, 1986, edition of the <u>D.C. Register</u>, (Vol. 33 page 4783) and transmitted to Congress on July 22, 1986 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-151, effective September 23, 1986.

D.C. ACT 6 - 193

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUL 1 6 1986

To amend the Home Purchase Assistance Fund Act of 1978 to expand the scope of eligibility assistance for recipients under the act.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "Home Purchase Assistance
Fund Act Amendments Act of 1986".

- Sec. 2. The Home Purchase Assistance Fund Act of 1978, effective September 12, 1978 (D.C. Law 2-103; D.C. Code, sec. 45-2201 et seq.), is amended as follows:
- (a) Section 2 (D.C. Code, sec. 45-2201) is amended by inserting the phrase "and moderate" immediately following the phrase "provide financial assistance to the residents of the District of Columbia of lower".
- (b) Section 5(b) (D.C. Code, sec. 45-2204(b)) is amended to add the following new subsection:
- "(3) Applicants who are residents of the District of Columbia shall include, for purposes of the fund, employees living outside the District of Columbia who are subject to the residency requirements of District of Columbia law,

D.C. Code, sec. 45-2201 (1987 supp.)

D.C. Code, sec. 45-2204 (1987 supp.) provided that an applicant meets all other eligibility requirements of the fund and will be a first-time homebuyer or real property purchaser.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
