"D.C. Pretrial Services Agency Executive Committee Act of 1986".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-443 on first and second readings, November 25, 1986 and December 16, 1986, respectively. Following the signature of the Mayor on January 8, 1987, this legislation was assigned Act No. 6-258, published in the January 23, 1987, edition of the D.C. Register, (Vol. 34 page 519) and transmitted to Congress on January 13, 1987 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-199, effective February 28, 1987.

D.C. ACT 6 - 258

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JAR 08 1987

To amend title 23 of the District of Columbia Code by changing the composition of the executive committee of the District of Columbia Pretrial Services Agency.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,

That this act may be cited as the "District of Columbia

Pretrial Services Agency Executive Committee Act of 1986".

- Sec. 2. Section 23-1304(a) of the D.C. Code is amended D.C. Code, s 23-1304 to read as follows: (1987 supp.)
- "(a) The agency shall function under the authority of and be responsible to an executive committee of 9 members of which 5 members shall constitute a quorum. The executive committee shall be composed of 5 persons appointed by the Mayor of the District of Columbia with the advice and consent of the Council of the District of Columbia, the chief judge of the United States Court of Appeals for the District of Columbia Circuit or his or her designee, the chief judge of the United States District Court for the District of Columbia or his or her designee, the chief judge of the District of Columbia Court of Appeals or his or her

designee, and the chief judge of the Superior Court of the District of Columbia or his or her designee.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
