"Interest Rate Ceiling Amendment Act of 1983 Clarification Act of 1985 Temporary Act of 1985".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-76 on first and second readings, January 16, 1985 and February 12, 1985, respectively. Following the signature of the Mayor on February 28, 1985, this legislation was assigned Act No. 6-12, published in the March 15, 1985 edition of the D.C. Register, (Vol. 32 page 1477) and transmitted to Congress March 4, 1985 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-2, effective April 23, 1985.

To amend, on a temporary basis, the Interest Rate Ceiling Amendment Act of 1983 by removing the 1-point limitation on federally related mortgage loans.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "Interest Rate Ceiling
Amendment Act of 1983 Clarification Act of 1985 Temporary
Act of 1985".

Sec. 2. The 2nd sentence of D.C. Code, section 28-3301(e)(2), is amended to read as follows:

Note, D.C. Code, se 28-3301 (1985 supp.)

"The first sentence of this paragraph shall not apply to any loan or financial transaction which is described in subsection (d) of this section or to any loan which is described in section 501(a)(1) of the Depository Institutions Deregulation and Monetary Control Act of 1980, approved March 31, 1980 (94 Stat. 161; 12 U.S.C. sec. 1735f-7, note).".

Sec. 3. (a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,

approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).

(b) This act shall expire on the 180th day following its having taken effect.
