D.C. LAW 6-211

"Employment Amendment Act of 1986".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-111 on first and second readings, November 25, 1986 and December 16, 1986, respectively. Following the signature of the Mayor on January 8, 1987, this legislation was assigned Act No. 6-271, published in the February 6, 1987, edition of the D.C. Register, (Vol. 34 page 847) and transmitted to Congress on January 13, 1987 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-211, effective February 28, 1987.

# D.C. ACT 6 - 271

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

## ZAN 0 8 1987

To amend the Youth Employment Act of 1979 to restructure the On-the-job training for adults with dependents program by eliminating the cap on reimbursable wages and on the number of persons who may participant in the program; to redefine the criteria for participation in the program; to require participating employers to agree to hire persons who have completed the program; and to delete language requiring the Mayor to appoint a task force.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Employment Amendment Act of 1986".

- Sec. 2. Section 2(a)(4) of the Youth Employment Act of D.C. Code, 36-702 (1979, effective January 5, 1980 (D.C. Law 3-46; D.C. Code, (1987 supp. sec. 36-702(a)(4)), is amended to read as follows:
- "(4) On-the-job training program for adults. An On-the-job training program for adults at least 18 years of age who are District of Columbia residents and unemployed. Priority for participation in the program shall be given to economically disadvantaged adults with dependents, with special consideration given to public housing residents. The District of Columbia government shall reimburse

participating employers 1/2 of the prevailing wage paid for an occupation, as determined by the Mayor, for a period not to exceed 12 months. The employer shall pay all wages in excess of the allowable reimbursement and all fringe benefits. The Mayor shall require that participating private sector employers agree to hire persons who successfully complete the program. Nothing in this section shall prohibit the participation of the Council of the District of Columbia in the On-the-job training program for adults.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,

approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
