"Cigarette Tax Amendment Act of 1985".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-188 on first and second readings, May 28, 1985, and June 11, 1985, respectively. Register</u>, (Vol. 32 page 3774) and transmitted to Congress on June 19, 1985 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

## D.C. ACT 6 - 4 8

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

## JUN 1 4 1985

To amend the District of Columbia Revenue Act of 1949 to modify the tax on cigarettes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Cigarette Tax Amendment Act of 1985".

- Sec. 2. The District of Columbia Revenue Act of 1949, effective March 10, 1982 (D.C. Law 4-71; D.C. Code, sec. 47-2401 et sec.), is amended as follows:
- (a) Section 603(a) (D.C. Code, sec. 47-2402(a)) is amended to read as follows:

"Except as otherwise provided in section 604, a tax is levied and imposed on the sale or possession of all cigarettes in the District of Columbia at the rate of 0.65 cents for each cigarette.".

(b) Section 604(a)(2) (D.C. Code, sec. 47-2403(a)(2)) is repealed.

Sec. 3. (a) Except as provided in subsection (b), this act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and

Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
