D.C. LAW 6-49

"Motor Vehicle Tags Temporary Amendment Act of 1985".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-273 on first and second readings, June 25, 1985, and July 9, 1985, respectively. Following the signature of the Mayor on July 16, 1985, this legislation was assigned Act No. 6-68, published in the August 9, 1985, edition of the <u>D.C. Register</u>, (Vol. 32 page 4585) and transmitted to Congress on July 24, 1985 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-49, effective October 5, 1985.

D.C. ACT 6 - 68

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUL 1 6 1985

To amend, on a temporary basis, the District of Columbia Revenue Act of 1937 to extend the period of validity for special use certificates and identification tags for motor vehicles.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "Motor Vehicle Tags
Temporary Amendment Act of 1985".

Sec. 2. Section 2(d)(5)(A) of title 4 of the District of Columbia Revenue Act of 1937, effective March 10, 1983 (D.C. Law 4-206; D.C. Code, sec. 40-102(d)(5)(A)), is amended by striking the word "twenty" and inserting the word "thirty" in its place.

Sec. 3.(a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).

(b) This act shall expire on the 180th day following its having taken effect.
