"Ban on Possession of Open Alcoholic Beverage Containers Act of 1985".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-185 on first and second readings, September 10, 1985, and September 24, 1985, respectively. Following the signature of the Mayor on October 9, 1985, this legislation was assigned Act No. 6-87, published in the October 25, 1985, edition of the D.C. Register, (Vol. 32 page 5970) and transmitted to Congress on October 10, 1985 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-64, effective December 3, 1985.

D.C. ACT 6 - 87

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

OCT 0 9 1985

To amend the Alcoholic Beverage Control Act to prohibit possession of open alcoholic beverage containers.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Ban on Possession of Open Alcoholic Beverage Containers Act of 1985".

- Sec. 2. Section 28(a) of the District of Columbia
 Alcoholic Beverage Control Act, approved January 24, 1934
 (48 Stat. 333; D.C. Code, sec. 25-128(a)), is amended by
 striking the phrase "drink any alcoholic beverage" and
 inserting the phrase "drink any alcoholic beverage or
 possess in an open container any alcoholic beverage" in its
 place.
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,
