"Dedication and Designation of Patricia Roberts Harris Drive, N.E., S.O. 85-189, and Street Naming Amendment Act of 1988".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-255 on first and second readings, February 2, 1988, and February 16, 1988, respectively. Following the signature of the Mayor on March 2, 1988, this legislation was assigned Act 7-147, published in the March 18, 1988, edition of the D.C. Register, (Vol. 35 page 2053) and transmitted to Congress on March 7, 1988 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-102, effective April 26, 1988.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To accept the dedication of land and to establish building restriction lines for a minor street located in Square 4325 connecting 31st Place, N.E., and Fort Lincoln Drive, N.E., within Fort Lincoln New Town in Ward 5 and to name the street Patricia Roberts Harris Drive; and to amend the Street and Alley Closing and Acquisition Procedures Act of 1982 to permit streets to be designated as drives.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Dedication and Designation of Patricia Roberts Harris Drive, N.E., S.O. 85-189, and Street Naming Amendment Act of 1988".

Sec. 2. Pursuant to section 304 of the Street and Alley Closing and Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law 4-201; D.C. Code, sec. 7-444), the Council of the District of Columbia accepts the dedication of land and approves the establishment of building restriction lines necessary to create a minor street in Square 4325 connecting 31st Place, N.E., and Fort Lincoln Drive, N.E., in Fort Lincoln New Town, as shown in the Surveyor's plat filed under S.O. 85-189.

Sec. 3. Pursuant to section 401 of the Street and Alley Closing and Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law 4-201; D.C. Code, sec. 7-451), the minor street created by the dedication referred to in section 2 shall be named Patricia Roberts Harris Drive.

Sec. 4. Section 402(d) of the Street and Alley Closing and Acquisition Procedures Act of 1982, effective Narch 10, 1983 (D.C. Law 4-201; D.C. Code, sec. 7-452(4)), is amended by striking the word "roads" and inserting in its place the phrase "roads, drives,".

D.C. Code, sec. 7-452 (1989 supp.) Sec. 5. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
