### D.C. LAW 7-105

"Protection for Foreign Officials, Official Guests, and Internationally Protected Persons Amendment Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-59 on first and second readings, December 8, 1987, and January 5, 1988, respectively. This legislation was deemed approved without the signature of the Mayor on January 28, 1988, pursuant to Section 404(e) of "the Act", and was assigned Act No. 7-138, published in the February 5, 1988, edition of the D.C. Register, (Vol. 35 page 728) and transmitted to Congress on February 1, 1988 for a 60-day review, in accordance with Section 602(c)(2) of the Act.

The Council of the District of Columbia hereby gives notice that the 60-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-105, effective May 7, 1988.

# D.C. ACT 7 - 13 8

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

## JAN 2 8 1988

To repeal the Joint Resolution To protect foreign diplomatic and consular officers and the buildings and premises occupied by them in the District of Columbia, effective upon enactment by the U.S. Congress of legislation that makes the federal law on this matter applicable to the District of Columbia.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Protection for Foreign Officials, Official Guests, and Internationally Protected Persons Amendment Act of 1987".

Sec. 2. The Joint Resolution To protect foreign diplomatic and consular officers and the buildings and premises occupied by them in the District of Columbia, approved February 15, 1938 (52 Stat. 30; D.C. Code, sec. 22-1115 et seq.), is repealed.

Sec. 3. This act shall take effect after a 60-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(2) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(2)), or upon enactment by the United States Congress of legislation amending An Act for the Protection of Foreign Officials and Official Guests of the United
