"Repeal of the Mandatory Retirement Age for Teachers in the District of Columbia Public Schools Amendment Act of 1988".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-393 on first and second readings, March 1, 1988, and March 15, 1988, respectively. Following the signature of the Mayor on March 31, 1988, this legislation was assigned Act No. 7-157, published in the April 15, 1988, edition of the <u>D.C. Register</u>, (Vol. 35 page 2674) and transmitted to Congress on April 7, 1988 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-111, effective May 21, 1988.

MAR 3 1 1988

To amend An Act For the retirement of public-school teachers in the District of Columbia in order to repeal the mandatory retirement age for teachers in the District of Columbia public schools.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Repeal of the Mandatory Retirement Age for Teachers in the District of Columbia Public Schools Amendment Act of 1988".

Sec. 2. Section 3 of An Act For the retirement of public-school teachers in the District of Columbia, approved sec. 31-1224 August 7, 1946 (60 Stat. 876; D.C. Code, sec. 31-1224), is (1989 supp.) amended by repealing subsection (c).

D.C. Code,

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,
