D.C. LAW 7-148

"Extension of the Moratorium on Retail Service Station Conversions Amendment Act of 1988".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-316 on first and second readings, June 14, 1988, and June 28, 1988, respectively. Following the signature of the Mayor on June 30, 1988, this legislation was assigned Act No. 7-200, published in the July 15, 1988, edition of the D.C. Register, (Vol. 35 page 5427) and transmitted to Congress on July 7, 1988 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-148, effective September 21, 1988.

To amend the Retail Service Station Act of 1976 to extend the moratorium on the conversion of full service retail service stations to limited service retail service stations; to extend the life of the Gas Station Advisory Board; to repeal the 7% restriction on service station conversions; and to require a study and final report by the Mayor.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Extension of the Moratorium on Retail Service Station Conversions Amendment Act of 1988".

Sec. 2. The Retail Service Station Act of 1976, effective April 19, 1977 (D.C. Law 1-123; D.C. Code, sec. 10-231), is amended as follows:

Section 10-231

- (a) Subsections (b) and (c) of section 5-301 are amended by striking the phrase "October 1, 1987" and inserting the phrase "October 1, 1991" in its place.
 - (b) Subsection (d)(2) of section 5-301 is repealed.
- (c) Subsection (e)(4) of section 5-301 is amended by striking the phrase "October 1, 1987, or when the ceiling established in subsection (d) of this section shall be reached, whichever date occurs first" and inserting the phrase "October 1, 1991" in its place.
- (d) Subsection (f) of section 5-301 is amended to read as follows:
- "(f) The Mayor shall study the motor vehicle repair, maintenance, and other services being offered by existing "full service retail stations" and "non-full service retail service stations" to residents, commercial establishments, commuters, and other affected persons in the District of Columbia, both in terms of adequacy and in terms of convenience. This study shall include an analysis of the impact of converting existing "full service retail service stations" to "non-full service retail service stations" in various areas of the District of Columbia. The Mayor shall

study the adequacy of existing retail service stations to serve the needs and convenience of residents, commercial establishments, commuters, and other affected persons with respect to the retail sale of motor fuels, petroleum products, and automotive products in various areas of the District of Columbia. The study shall include an examination of the petroleum products and automotive products being offered by commercial establishments other than retail service stations. The Mayor shall, if necessary, present to the Council a preliminary report within 30 days after the effective date of the Extension of the Moratorium on Retail Service Station Conversions Amendment Act of 1988. A final report detailing the findings of the study, including the Mayor's recommendations or proposals with respect to any necessary or desirable legislation or other actions, shall be submitted to the Council no later than June 1, 1989.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
