
NOTICE

D.C. LAW 7-155

"District of Columbia Traffic Amendment Act of 1988".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-414 on first and second readings, June 28, 1988, and July 12, 1988, respectively. Following the signature of the Mayor on July 15, 1988, this legislation was assigned Act No. 7-210, published in the July 29, 1988, edition of the D.C. Register, (Vol. 35 page 5718) and transmitted to Congress on July 25, 1988 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-155, effective September 29, 1988.

AN ACT

D.C. ACT 7 - 210

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

EFFECTIVE DATE JUL 15 1988

To amend the District of Columbia Traffic Act of 1925 to require the Mayor to permit individuals to register to vote in the District of Columbia when they apply for or renew their operator's permit or identification card.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Traffic Amendment Act of 1988".

Sec. 2. Section 7 of the District of Columbia Traffic Amendment Act, 1925, approved March 3, 1925 (43 Stat. 1121; D.C. Code, sec. 40-301), is amended by adding a new subsections (a-1) to read as follows:

Section 40-301


"(a-1)(1) The Mayor and the Board of Elections and Ethics shall jointly develop an application form and a change of name and address form by January 1, 1989, which shall allow an applicant wishing to register to vote to do so by the use of a single form containing the necessary information for voter registration and the information required for the issuance, renewal, or correction of the applicant's driver's permit or identification card.


"(2) Commencing not later than May 1, 1989, the Mayor shall provide each qualified elector who applies for the issuance, renewal, or correction of any type of driver's permit or for an identification card an opportunity to complete an application to register to vote by use of a single form containing the necessary required information for the issuance, renewal, or correction of the driver's permit or identification card.

"(3) The Mayor shall forward all new applications to the Board of Elections and Ethics within 10 days of receipt.

"(4) Applications received from the Mayor shall be considered received by the Board of Elections and Ethics as of the date the application was made."

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
