"District of Columbia Latino Community Development Act Amendment Act of 1988".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-362 on first and second readings, June 28, 1988, and July 12, 1988, respectively. Following the signature of the Mayor on July 15, 1988, this legislation was assigned Act No. 7-227, published in the July 29, 1988, edition of the <u>D.C. Register</u>, (Vol. 35 page 5754) and transmitted to Congress on July 25, 1988 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-171, effective September 29, 1988.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUL 1 5 1988

To amend the District of Columbia Latino Community Development Act to allow members of the Commission on Latino Community Affairs to continue to serve beyond the end of their appointed terms.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Latino Community Development Act Amendment Act of 1988".

Sec. 2. Section 404 of the District of Columbia Latino Community Development Act, effective September 29, 1976 (D.C. Law 1-86; D.C. Code, sec. 1-2324), is amended by striking the third sentence and inserting the following sentence in its place:

"A member may continue to serve until a successor is

appointed.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia

Statutes-at-Large, or the District of Columbia Municipal

Regulations.
